# 1- Before you start!

In order to complete the application form, you need to prepare the documents listed below.

We advise you to complete the documents listed below before starting completing the **Official Application Form**.

## 1- Organization Tax Identification Document

A document that shows the registration of the organization within the local tax system.

## 2- Representative's Identification Document

A valid ID document of the person representing the organization for the Award (Ex: Passport, ID)

## 3- Representative's capacity certification Document

A document that shows that the representative has the legal capacity to represent the organization (e.g: a document showing the organigram, the entity statutes, an authorisation from the CEO, etc.)

## 4- Bank Account Certificate

A document issued by your organization's bank confirming the ownership of the bank account.

## 5- Technical Annex Document (Technical Report)

This is a supplementary long form that would explain all the details of your organization. This form will have to be completed, and then downloaded to be attached to the Official Application form. To see the questions you will have to answer, you can check the reference document in the [Help Section](#) (click on "*Canvi d'idioma*" to see the page in English).


Please follow this guide that will show you how to complete the technical annex document.

## 2- Technical Annex Document

The technical annex document is required to be attached to the Official Application Form in order to complete the submission. To complete the technical annex document, you need to follow the below steps. Please note that you can save your work and continue later before your final submission.

1- Go to: [www.arc.cat/wemedaward/](http://www.arc.cat/wemedaward/)

2- Create an account

Click on “Create new user”, fill out the information details and save.  
You will receive an email with a password that you can change.

3- Complete “Identification” section



In the section “Basic Information on the Sustainable Business”, “Registration Date” refers to the date the organization was registered.

Please note that if you are applying for “Early Stage” the date of registration should be no longer than 3 years back. For “Growth Stage” applicants, the date has to be at least 3 years back.

Also note that the maximum number of employees permissible is 250.

This will download a PDF document that contains all the information that you entered. Once signed, this document will be ready to be uploaded to the Official Application Form.

## 9- Sign the Technical Annex

This step would be considered complete if you successfully attach an image of your signature to the form.

If for some reason that is not possible, you can do the following:

After downloading the document, you need to sign it digitally using Adobe reader, or alternatively, you can print, sign by hand, scan, and save the document to be uploaded.

### 3- WeMed Official Application Form

Now that you have all the required documents ready, including the completed and downloaded Technical Annex document, you can proceed to completing the Official Application Form.


